Armed Forces Tribunal situated in West Block VIII, R. K. Puram invites quotations for carrying out pest control services in its premise and common areas. The vendor shall examine the premise carefully and locate areas of critical pest activity.

2. The vendor shall perform the service items specified as follows :-

Items	Frequency
General Pest Control	Alternate Month
Rodent Control	Alternate Month
Fogging	Twice in a year

- Note;- (i) In the event of reinfestation within the service period due to the menace of mouse in the premises, the vendor shall render additional treatment as necessary at no extra cost.
  - (ii) If neither infestation or threatened infestation nor reinfestation has been done in reasonable time the payment for that treatment, if got done by AFT from market would be deducted from the payment of the contractor.
  - (iii) Transportation charges, what so ever shall not be paid by AFT (PB) for any type of services.
- 3. (a) The Vendor shall undertake to minimize the negative impact of the pest control service on the environment.
  - (b) The Vendor shall make every endeavor to safeguard health and safety of people in the AFT(PB)'s premise against any perils of using pesticides.
  - (c) All pesticides that will be used by the Vendor must have been registered in accordance with Pesticides Ordinance (Chapter 133).

- (d) The Vendor shall ensure that its agents, workers or employees, who apply pesticides in the AFT(PB)'s premise, must be sufficiently trained to carry out the pest control services correctly and safely.
- (e) The Vendor has to enclose the copies of similar current contract(s) in Govt. offices.
- 4. The Vendor shall provide all necessary tools, applicators, device, equipment and supplies for the performance of its services under this Contract. Such tools, applicators, device, equipment and supplies must be at all times kept in good working order.
- 5. The AMC will commence from the date the L1 vendor starts work of pest control on the site of AFT(PB) New Delhi.

## PAYMENT TERMS AND CONDITIONS.

- 6. The payment to the vendor will be made on quarterly basis at the end of each quarter against invoice with PAN number, raised by the vendor and based on satisfactory service provided by the vendor.
- 7. GST, TDS and any other applicable taxes as per prevailing rates, will be deducted before making the payment.
- 8. The vendor may visit the office campus before quoting the rates, if desired. The quotations should reach latest by 1600 hrs on  $\underline{09-01-2023}$
