CIRCULAR

Applications are invited for filling up of the following posts in the Armed forces Tribunal, Kolkata Bench, Kolkata on deputation basis and/or re-employment on contract basis for a period of one year from amongst serving/retired Government servants who fulfil the eligibility conditions/criteria as under:-

1	Deputy Registrar	PB-3 (Rs.15600-39100) + GP-6600/-	Officers of the Central Government or State Government or High Court/ District Courts:- (a) (i) Holding an analogous post on regular basis; or (ii) With at least five years regular service in the scale of pay Rs. 8000-275-13500 (pre-revised), or (iii) With at least eight years regular service in the scale of pay of Rs. 6500-10500 (pre-revised) or equivalent, and (b) Possessing a degree in law from a recognized University or equivalent.

- The pay of the officer selected will be governed in accordance with DOP&T O.M. No. 6/8/2009-Estt.(Pay-II) dated 17.06.2010 as amended from time to time.
- The maximum age limit for appointment on deputation shall be 56 years as on the closing date for receipt of applications. The maximum age limit for the re-employment on contract basis is 62 years. The appointment of the retired Government officers/officials will be made only on contract basis on usual terms of pay fixation. The gross pension will be deducted from the pay fixed. Such appointments will be made for a maximum period of one year or till posts are filled up as per RR on regular basis, whichever is earlier.
- The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.
- The applications in the prescribed Proforma (Annexure I) from eligible officers who can be spared in the event of their selection may be forwarded to the undersigned latest by 5th March, 2012 along with ACR Dossiers of the candidate concerned or photo copies thereof for the last five years and a Vigilance Clearance Certificate to the effect that 'No departmental/Criminal Proceedings are pending or being contemplated against the official concerned'.
