ORDER

Heard learned counsel for the appellant.

Leave to appeal is granted.

The appellant was downgraded to Low Medical Category (LMC) w.e.f. 04.07.2017 for Diabetes Mellitus Type II. He was discharged on medical grounds w.e.f. 13.11.2019. The order of discharge was challenged by the Appellant before the Armed Forces Tribunal. The Armed Forces Tribunal dismissed the Original Application, aggrieved by which the above appeal is filed.

The Appellant contended before the Tribunal that he was promoted as Subedar on 01.05.2019 as he was found to be in acceptable medical category and is entitled to continue till 31.08.2026. On behalf of the Respondents, it was contended before the Tribunal that the Appellant was promoted as Subedar on 01.05.2019 as he fulfilled the criteria for promotion. However, as there is no sheltered

appointment available for his retention, he was discharged on medical grounds in the interest of organizational efficiency of an operational unit. The Respondent further contended that Ladakh Scouts has five battalions. Four battalions out of the five are deployed in the high-altitude area in Ladakh whereas only the 5th battalion is rotated at Chandi Mandir, a peace station.

Personnel in lower medical category of the 5th battalion being posted to the battalion in Chandi Mandir adversely affects the organizational efficiency of the Unit. The Tribunal accepted the submissions on behalf of the Respondents. We are in agreement with the Tribunal.

For the aforementioned reasons, the appeal is dismissed. Pending application(s), if any, shall stand disposed of.
