Heard Mr.M.Selvaraj, learned counsel for the applicant and Mr.E.Arasu, learned Central Government Standing Counsel, assisted by Maj Suchithra Chellappan, learned JAG Officer (Army), appearing on behalf of the respondents.

While submitting his arguments, the learned counsel for the applicant has come forward to withdraw this Original Application for the purpose of approaching the Government for grant of pension under the provisions of Pensions Regulation for the Army 1961 (Part I) and, thereafter, to approach this Tribunal, if necessary. The learned counsel for the applicant was permitted to make an endorsement to that effect on the main application and the same was also recorded by the applicant's counsel.
