1. Objections to Calculation Memo has been filed. On a perusal, we find that the arrears payable to the applicant with effect from 04.03.2010 to 30.09.2014 comes to Rs.3,25,989/-. Col S.K. Varshney, Additional Legal Officer (Army) represents that the order passed by this Tribunal granting Reservist Pension to the applicant is likely to be executed in six weeks. Hence, post the case on 10.12.2014 for compliance of the order of this Tribunal. In default, the respondents shall deposit a sum of Rs.2,50,000/- (Rupees two lakh fifty thousand only), i.e., approximately 75% of the arrears to the credit of the Original Application for being withdrawn by the applicant.
