## CIRCULAR

- 4. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of applications.

The application in the prescribed proforma (Annexure) of the eligible officer, who can be spared in the event of his/her selection may be forwarded to the Registrar, Armed Forces Tribunal, Regional Bench, Srinagar at Jammu, Four Majors Qtrs P-6(1 to 4), Military Station Sunjuwan, Jammu-180011 by the Department latest by 05 Dec 2023 along with photo copies of the Annual Confidential Reports for the last five years (where applicable) of the candidates along with Vigilance Clearance Certificate.
