Apart from the monthly consolidated remuneration, as mentioned above, subject to TDS, Consultants shall not be entitled to any kind of allowances such as Dearness Allowance, Conveyance Allowance, House Rent Allowance and any other facilities like Residential Accommodation, Personal Staff, Transport, CGHS and Medical Reimbursement, etc.

- 4. Consultant to be engaged on full time basis shall not be permitted to take up any other assignment during the period of their consultancy in the Armed Forces Tribunal, Regional Bench, Lucknow.
- 5. Consultants shall be eligible for 01 (one) day's leave for each completed month of his/her term as Consultant on *pro rata* basis. The unavailed leave will not be carried over to the next term.
- 6. The engagement of Consultants is purely contractual in nature initially for a period of six months, which may be extended, subject to approval of the competent authority.
