Personal Staff, Transport, CGHS and Medical Reimbursement etc.
- 4. Consultants to be engaged on full time basis shall not be permitted to take up any other assignment during the period of their consultancy in the Armed Forces Tribunal, Regional Bench, Jaipur.
- 5. Consultants shall be eligible for 1.5 day's leave for each completed month of his/her term as Consultant on pro rata basis. The unavailed leave will not be carried over to the next terms.
