1. Apart from the monthly consolidated remuneration, as mentioned above, subject to TDS, Consultant shall not be entitled to any kind of allowances such as Dearness Allowance, Conveyance Allowance, House Rent Allowance or any other facilities like Residential Accommodation, Personal Staff, Transport, CGHS and Medical Reimbursement etc.
- 4. Consultant to be engaged on full time basis shall not be permitted to take up any other assignment during the period of their consultancy in the Armed Forces Tribunal, Regional Bench, Chennai.

- Consultant shall be eligible for 1.5 day's leave for each completed month of his/her term as 5. Consultant on pro rata basis. The un-availed leave will not be carried over to the next term.
- The engagement of Consultant is purely contractual in nature initially for a period of one year, 6. which may be extended, subject to approval of the competent authority.
