1. Apart from the monthly consolidated remuneration as mentioned above, subject to TDS, Consultants shall not be entitled to any kind of allowance such as Dearness Allowance, Conveyance Allowance, House Rent Allowance, or any other facilities like Residential Accommodation, Personal Staff, Transport, CGHS and Medical Reimbursement etc.
- 4. The Consultants to be engaged on full time basis shall not be permitted to take up any other assignment during the period of the+ consultancy in the Armed Forces Tribunal, Regional Bench, Kochi.
