2. Consultant should be well acquainted with the functioning of Central Government or its departments and various rules/regulations issued by Central Government from time to time.

3. Apart from monthly consolidated remuneration, as mentioned above, subject to TDS, Consultant shall not be entitled for any kind of allowances such as Dearness Allowance, Conveyance Allowance, House Rent Allowance or any other facilities like Residential Accommodation, Personal Staff, Transport, CGHS and Medical Reimbursement, etc.

4. Consultants to be engaged on full time basis shall not be permitted to take up any other assignment during period of their consultancy in the Armed Forces, Regional Bench, Srinagar at Jammu.

5. Consultant shall be eligible for 01 day's leave for each completed month of his/her term as Consultant on *pro rata* basis. The unavailed leave will not be carried over to the next term.

6. The engagement of Consultants is purely contractual in nature initially for a period of six months, which may be extended, subject to approval of the competent authority.

7. The engagement of consultants can be terminated at any time without assigning any reason whatsoever. However, if the consultant is not willing to work for any reason whatsoever, he/she will have to give a minimum one month's notice to the office. The decision of the HoD Regional Bench Srinagar at Jammu shall be the final in all respects.

8. Consultants shall follow the normal working hours as prescribed from 9.30 am to 5.30 pm. However, as per exigencies, they may be required to sit late to complete the time bound work.


9. The maximum age limit for engagement of consultant shall not exceed 65 years as on the closing date of receipt of applications.

11. The applications received without supporting documents, photograph, unsigned and incomplete in any manner, or if information furnished is found false or if applicant has suppressed any material information, the application of such candidate shall be rejected summarily.
